Dear Robert:

I have been in contact with you before on a different matter. I sent you a Case File by Express Mail EK238861084US, that you received on March 29, 2000 at 9:11 AM. However, I am writing you now with two cases that I want to bring to your attention, so you can bring criminal charges against the Veterans Administration for violating the Charter that they operate under.

I am enclosing two different sides of a 22 year Appeal that I have with the Board of Veterans Appeals and the Veterans Administration. I wrote the Substantive Appeal of George Ojala first. This portion of my appeal was opened by a letter to Al Gore and the White House, as documented in the enclosures. It is 84 pages long and includes the Regulations that the VA is suppose to operate under and "has violated."

I decided to go through my documentation and give you my side of the "original error" created by the Veterans Administration. I call it the "ORIGINAL DOCUMENTATION OF CLAIM AGAINST THE VETERANS ADMINISTRATION BY GEORGE OJALA" It is 28 pages long and shows the truth of the records.

I also want you to bring criminal charges against the IRS for covering up an investigation into violations by the Reverend Jerry Falwell of his tax-exempt status.

I also want Jerry Falwell prosecuted for his outstanding violation when he formed the Liberty Foundation with over 12 million dollars to "elect conservative candidates". What the enclosed case shows is that he got away with his political activities for over two plus years, without the IRS doing anything. When called on the carpet, the IRS bailed out of the investigation and Jerry did so two weeks later.

In closing, I feel that it is your responsibility to inform the White House of both of these cases, as soon as possible. The VA case was started or opened by Al Gore and the White House. The IRS was part of the President's attempt to reform the IRS. This enclosure shows "Political Favoritism" or "Special Privilege" for Mr. Falwell. This issue was not brought up so it could be dealt with.

I am going to use you as my "point man" when I start writing the letters to the CC: people at the end of this letter. I have given you ample time to deal with the first case file I dealt you. I haven't heard anything back from you.

I am going to mail this tomorrow and give you the time to get this and get going. When I get back and start writing again I will be giving this letter to everyone I choose to write to. I have done my homework to the Nth degree. How about doing yours?

COVERUP BY THE IRS USING POLITICAL OR EXECUTIVE PRIVILEGE CONCERNING THE REVEREND JERRY FALWELL AND THE LIBERTY FOUNDATION

This enclosed brief details over 2 years of letter writing to the IRS (January 13, 1986 to May 31, of 1988) about Jerry Falwell's violation of his non-profit status.

This constitutes a coverup because the Director of Employee Plans and Exempt Organizations - Operations Division, never signed this investigation off. Someone, by the name of F Hallikan (see last letter in brief) signed it for him.

This man did enclose the text of the "Testimony of Lawrence B. Gibbs - Commissioner of Internal Revenue" before the Subcommittee on Oversight House Ways and Means Committee on October 6, 1987. This gives the basis rules the IRS used at that time for the "Jerry Falwell's". It actually proves the points I make in my letters.

With this information, all you need to do, is run a check through the IRS on any Investigations done on Jerry during this time span. I bet you a million they don't have anything.

What you will find when you do get to dig into his financial history, is that he was bought and payed for by Maxxam and the Corporate Raider, as documented in the Kangas Report. You will find that these people have probably financed the entire Right Wing Fundamentalist Christian Movement, as well.

SUMMARY: The enclosed packet consists of seven letters that were sent and received between January 13, 1986 and May 31, 1988.

The purpose of the January 13, 1986 letter was to inform the IRS that the Reverend Jerry Falwell was openly violating his "Tax Exempt Status for Religious Organizations."

Mr. Falwell announced that he was forming the Liberty Foundation (Federation) with a \$12 million dollar budget around that time. His stated purpose was "to elect conservatives to public offices throughout the country."

It took another letter, sent four months later, to get a response from the IRS. I then sent the {enclosed} October 16, 1986 letter to the "Problem Resolution Office" where I included a copy of a Jack Anderson Column dated: Friday, August 22, 1986.

Mr. Anderson states in his MINI-EDITORIAL: "The Liberty Federation (formerly the Moral Majority), the Rev. Jerry Falwell's fundamentalist religious group, is supposed to be politically neutral, interested in saving souls regardless of party affiliation. Yet its recent rating of members of Congress declared that nine of the 10 best are conservative Republicans and nine of the 10 worst are liberal Democrats. Funny how these things work out, isn't it?"

I then received a reply on September 30, 1986 from a Problem Resolution Officer named: Richard C. Thompson. He states "they have the above inquiry in the Problem Resolution Office for special processing." "We are working on it and will be in touch with you by Nov. 05."

I never heard back from them. I wrote four or more letters to the IRS without any answers (I didn't find copies of these).

I finally wrote Congressman Doug Bosco about the IRS's two year coverup. This is in April of 1988. His June 6, 1988 response to me is enclosed. "He says he gave my letter to the Commissioner's Office at the Internal Revenue Building."

The last letter is dated May 31, 1988 and is from the Office of the Director of Employee Plans and Exempt Organizations - Operations Division. This is in response to Congressman's Bosco's Inquiry.

This is a "brush off" letter in that it states..."we cannot disclose what action the service may have taken or may take with respect to any taxpayer"

They do include a copy of Commissioner Gibb's October 6, 1987, testimony before the Subcommittee on Oversight of the House Ways and Means Committee about Service administration of the Federal tax rules applicable

to tax exempt organizations involving television ministries.

I refer to Page Five of Commissioner Gibb's Testimony where he outlines the five basic tests that Jerry Falwell's "Tax Exempt Entitlement" is based on. Mr. Gibb states at Number (4) Four, that 'IT MAY NOT PARTICIPATE OR INTERVENE IN POLITICAL CAMPAIGN ACTIVITY;'

This constitutes a Political Cover Up by the IRS, because they failed to follow the Regulations and enforce the law, as it pertains to Jerry Falwell and his Political Activities.

I refer to the signature on this letter. The Director, R. E. Withers is suppose to have written this letter. He doesn't sign it. Someone else signs the letter, "for" Withers. The Director probably wasn't even made aware of this action.

I feel that the Rev. Jerry Falwell was informed of this investigation. He publicly withdrew from the Liberty Federation and "Politics" within weeks of my receiving the above letter.

Close:

I have written the IRS within the past year or so, about the above documentation. I included the same packet and asked that they look into "Political Favoritism" as something they needed to reform. I haven't heard anything back.
